Project Overview

The City of Nortonville seeks funding from the U.S. Department of Transportation (USDOT) for funding available through the Safe Streets and Roads for All (SS4A) for development of their first Comprehensive Safety Action Plan.

SS4A is a discretionary BIL program that has a local match requirement of 20%. The City of Nortonville is requesting \$20,000 from the Build Kansas Fund. This request has the potential to unlock \$80,000 in federal funds.

The next deadline for SS4A applications is May 16, 2024. The Build Kansas Fund application was received on March 15, 2024.

Overview

Nortonville, Kansas, a close-knit community, nestled amid the rolling plains, embodies the heart and soul of rural America. The city council and mayor are prepared to take a proactive approach to safety concerns and understand the need for pre-emptive measures and implement the Nortonville Safety Task Force (Task Force) to support the development of the Comprehensive Safety Action Plan for the City of Nortonville (Action Plan). This plan will encompass various initiatives aimed at enhancing public safety, promoting community engagement, and reducing injuries, especially serious and fatal injuries. The Safe Streets and Roads for All (SS4A) Grant, Nortonville will conduct supplemental planning activities to assist in the development of an Action Plan to create a safer and more secure future for all road users.

This project will consist of the development of the Action Plan as well as supplemental planning activities to include safety analysis for lighting and speed studies, road safety audits, and ADA transition plans. The Task Force will engage the community through various methods, and compile the feedback and update any policies. The SS4A grant will allow the city to identify comprehensive improvements, driven by data, community input and equitability matters to address safety concerns for all modes of transportation which will recommend an implementation timeframe. As countermeasures are implemented, the community will be updated and data will be shared to show the progress toward reducing injuries.

Project Location/Address

Nortonville, Kanas, located in Jefferson County, has nearly 7 miles of roadway with no connectivity for non-motorized users without using the road; this is a safety risk to the pedestrians. The proposed project will develop an Action Plan that will allow for safer modes of transportation for all users. Focus will be given to areas with the highest volumes, low-income residents and where residents with mobility and accessibility issues are a concern.

Response to Selection Criteria: Safety Impact

The City of Nortonville is fortunate enough to have avoided roadway fatalities in the last five years; however, safety concerns such as elderly residents using micromobility devices to travel and the lack of sidewalks and ADA ramps. The SS4A funds will allow the city to complete an Action Plan to identify low-cost and high-impact strategies throughout the older and newer parts of the community creating cohesiveness and connectivity for the residents. Implementing evidence-based projects and strategies improves the effectiveness of the improvements as well as the likelihood that the improvements will be utilized.

Osage Street, the north/south thoroughfare, connects residents to the gas station, the business district, via Main Street, and the Elementary/Middle School via Walnut Street. These areas are highly traveled by pedestrians, either elderly using micromobility devices or children on bikes, scooters or walking. There is a potential for severe and even fatal crashes. Also, dedicated facilities have been shown to increase the community's activity level and improve health.

Identifying areas where speeding is a concern and providing countermeasures will help reduce those risks. Additionally, improving lighting conditions and reducing conflict points by providing the pedestrian or cyclist a dedicated travel way separate from the motorist will also reduce the severity and likelihood of crashes.

Response to Selection Criteria: Equity

The city takes inclusivity and equity seriously and had Governmental Assistance Services conduct a Low-Moderate Income study in 2020 which shows that more than 60% of the residents have incomes that are below the LMI limits. The Task Force will include strategies and projects that improve the safety of all residents regardless of their income. Experts are in agreement that providing accessible improvements to low/moderate income areas increase the probability that the improvements will be utilized which improves health. One area in which Nortonville residents are statistically vulnerable is with their health. According to the USDOT Equitable Transportation Community Explorer, Nortonville has an overall disadvantaged component score of nearly 80% in health vulnerability. These Action Plan will address these issues, provide connectivity and begin the journey for improved health. This is especially important to Nortonville since nearly 20% of the residents are over 70 and on a very low-fixed income.

Additional Consideration: Budget Costs

The Nortonville City Council requests grant funding in the amount of \$80,000 to support the development and creation of the Action Plan and supplemental planning activities to aid in the guidance of the Action Plan. The city has requested \$20,000 in funding from the Kansas Build Fund as the 20% match. The Action Plan and supplemental planning activities represent a proactive and collaborative approach to addressing transportation safety challenges and presents a significant opportunity to address lacking transportation safety improvements within the community while fostering economic growth and enhancing quality of life. With the funding from the SS4A Grant, the City of Nortonville is poised to implement strategic improvements that will increase road safety, enhance pedestrian and cyclist infrastructure, and promote safe transportation practices. Together, the city can create a transportation environment that is safer, more accessible, and more conducive to the well-being of all residents of Nortonville.

Project Readiness

The city council is prepared to complete the consultant agreement with Blue Valley Consultants, LLC, a woman-owned, disadvantaged business, in preparation for being selected for this grant. Once the notice of award is given and the agreement executed with the DOT, the city council and Mayor will create the Nortonville Safety Task Force, data will be collected for the lighting and speed studies and road safety audits will be conducted. It is expected that the Comprehensive Safety Action Plan for the City of Nortonville will take 12 to 18 months to complete.
